41-22 RESOLUTION FOR INVESTMENT OF INTERIM MONEYS
(Revised Code 135.142)

WHEREAS, the Ohio Revised Code authorizes any Board of Education to authorize, by a two-thirds vote of its members, investments by its Treasurer of up to forty percent of interim moneys in certain notes and obligations; and

WHEREAS, the Treasurer of Northwest Local Schools has completed required training for making the type of investments authorized by the Ohio Revised Code, the type and amount of which training has been approved by the Treasurer of State; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the Northwest Local School District, at least two thirds of all members elected hereto concurring, that the Treasurer is authorized to invest up to forty percent of the interim moneys available for investment in either commercial paper or bankers' acceptances determined by the Treasurer in the manner described in the Ohio Revised Code.
